We have not finished compiling all the plans being considered for WGC's future. But, to give you a flavor of your Board's direction, here's a small sampling of some key goals, and examples of what that may mean to you:

Financial Stabilization – Meet departmental budgets; when revenue projections or collections change, then expenses or services will be adjusted (and vice versa). E.g. There should not be surprise deficits except for emergencies; Hours of operation or services may change.

Greater Participation – Increase membership, golf play, and restaurant usage. E.g. Public play pricing will be dynamic to optimize tee sheets; Certain house events, such as Poker Night, will accommodate non-members.

Customer Satisfaction – Enhance member and patron golf and restaurant experience. E.g. Survey members and patrons to gage what is preferable. Use feedback to help drive course maintenance priorities, restaurant options, social events, and tournament formats.

Transparency – Address all questions and concerns at committee and/or board level. E.g. I have been asked a lot of questions about the food minimum, so allow me to clarify (see pg 4 – Food Minimum Q&A)

Food Minimum Q & A

1) How is the food minimum billed?

The \$50/month food minimum is billed quarterly – this means that you really have 3 months (JAN-MAR; APR-JUN; JUL-SEP; OCT-DEC) to spend \$150. So, if you will be gone for a month to 6 weeks, you can comfortably spend the minimum while you are here. But, if you will be gone for 2 months or so during any quarter, see Arik.

- 2) If I pay cash or credit, will my bill still count towards my minimum? Yes. If the tab is under your name, the restaurant bill will accrue to your "food minimum" account, regardless of payment type.
- 3) Do pro-shop purchased drinks & snacks count towards food minimum? No. The LightSpeed system can not combine the registers from different departments. However, if you need pro-shop food and snacks to meet the minimum, then ask for a receipt on your account. SAVE those receipts (onus on you) and 10 days prior to the end of each quarter, bring the receipts to Arik and he will manually adjust your food minimum account.
- 4) How do I know if I will meet my minimum?

The LightSpeed system does not allow you (or us) to query a single account for an itemized report, so the easiest method is to save or record your own receipts. Arik will run a member-wide "food minimum" report about one week prior to the end of each month (when he runs other financial reports). So, if you need to know, ask Arik about a week prior to the end of the month or quarter.

Note: Remember, the food minimum is optional. If you choose to opt out for the year, then only \$30/month will be added to your bill.
